## ASA Gold and Precious Metals Limited Reports Financial Results for the Nine Months Ended August 31, 2015

San Mateo, CA, September 24, 2015 – ASA Gold and Precious Metals Limited (NYSE:ASA) reported that the total return for the nine months ended August 31, 2015, based on ASA's net asset value (NAV), was negative 22.5%, including the reinvestment of dividends. On August 31, 2015, the NAV of the Company was \$8.89 per share versus \$11.50 per share on November 30, 2014.

For the nine months ended August 31, 2015, the total return based on ASA's share price was negative 25.1%. The return for the FTSE Gold Mines Total Return Index during the same period was negative 21.3%.

The closing price of ASA's shares on the New York Stock Exchange (NYSE) on August 31, 2015 was \$8.03, representing a share price discount to NAV of 9.7%. The share price of closed-end funds, such as ASA, is determined by trading activity in the open market and consequently may reflect a premium (higher than) or discount (lower than) to its underlying NAV.
