ASA Gold and Precious Metals Limited Reports Financial Results for the Year Ended November 30, 2013

San Mateo, CA, January 28, 2014 – ASA Gold and Precious Metals Limited (NYSE:ASA) reported that the total return for the year ended November 30, 2013, based on ASA's net asset value (NAV), was negative 45.6%, including the reinvestment of dividends. At November 30, 2013, the NAV of the Company was \$12.98 per share versus \$24.18 per share a year earlier.

For the year ended November 30, 2013, the total return based on ASA's share price was negative 41.1%. The return for the FTSE Gold Mines Total Return Index during the same period was negative 52.3%.

The closing price of ASA's shares on the New York Stock Exchange (NYSE) on November 29, 2013 was \$12.78, representing a share price discount to NAV of 1.5%. The share price of closed-end funds, such as ASA, is determined by trading activity in the open market and consequently may reflect a premium (higher than) or discount (lower than) to its underlying NAV.
